## LAWS, RULES AND REGULATIONS

Proposed changes:

Interpretive Statement: The following changes are presented to make corrections, alterations and amendments to the previously approved Law book due to inadvertent omissions, changes, deletions and alterations made in error.

- 1. In all areas, change MUST and WILL back to SHALL (this is to become consistent, as has been traditionally referred to in the Laws, Rules & Regulations)
- 2. In all areas, change PLURAL back to MULTIPLE
- 3. In all areas, change TRUSTEES to TRUSTEE
- 4. In all areas, change HOST to HOSTS

- 5. P-6 Lines 2 & 3 add "your" in questions
- 6. P-6 # 7 Change "God" to "the existence of a Supreme Being?" (per our application)
- 7. P-6 # 9, 10 & 17 Delete in its entirety, all others move up accordingly
- 8. P-7 Balloting Remove entire first paragraph (most of the time, members don't know ahead of the meeting that balloting will occur)
- 9. P-9 second line change "who have been" to "who wish to be"
- 10. P-12 second line change "who have been" to "who wish to be"
- 11. P-14 in Associate Conductress paragraph change "who have been" to "who wish to be"
- 12. P-15 Second to last paragraph correct spelling of "Rules"
- 13. P-16 Last paragraph before >>>> Or <<<<< Remove the word "(Done)
